

Plover Police Report (2018 year-end)

2018 was a one of the busiest years in Plover Police Departments history. Highlighted below indicates a comparison between 2017 and 2018 as well as some of the major highlights and activity of 2018.



Plover Police had several staffing changes/assignments/promotions over 2018 and one of the major highlights of 2018 was the ability of our training unit (field training and department training coordinator) to maintain mandatory training requirements of all personnel and train new employees to established standards. Plover Police Department hired a new records clerk, 5 new officers, promoted one new sergeant and created one new detective position. The experienced officer hiring program proved to be invaluable in helping select quality applicants with a proven track record. Plover Police department is at full staff of 20 sworn officers and 3.5 civilian records staff.

Plover Police participated in numerous community related activities in 2018 while maintaining a very positive relationship with the community, notable events PPD was involved in: Celebrate Plover Committee, Mark Toyota Safety Fair, Guns and Hoses benefit for Veterans, Cops on Rooftop Special Olympics, Cops n Bobbers, Shop with a Cop, Citizen Academy, Chaplain Program, Trick or Treat at PD and numerous safety presentations.

Plover Police Department experienced record call volume and a substantial increase in proactivity of officers. This is attributed to enhanced record keeping practices, proactive employee, and overall growth within the village. The 2018 numbers are a reflection of Plover Police Activity.
